Dear Oostburg School District families,

The School District of Oostburg does not offer a summer feeding program for students that participate in the Free & Reduced hot lunch program. However, the Summer Food Service Program (SFSP) ensures that children can continue to receive nutritious meals when school is not in session. The SFSP does provide a Summer Meal Site Finder that is a free, web-based application that features a searchable map to help locate sites serving summer meals throughout the country. Each school year, the School District of Oostburg offers Free or Reduced Hot Lunch prices through the National School Lunch Program (NSLP) for families that qualify. For the 2019-20 school year, Free & Reduced lunch applications will be emailed to each household after Aug. 8, 2019. Additional application paper copies will be available in each school's office or you can go online to print off at your convenience. Please visit the school's website at: <http://oostburg.k12.wi.us/resources/#food>, to select Online Application Instructions for more detailed information and/or go to Free & Reduced Application for copies to print off for manual submission. Please submit F&R applications after Aug. 8, 2019, not before.

The Infinite Campus online application process is accessed through the parent portal. There are instructions throughout the process, as you go through it. It is recommended that you gather all household income information, Food Share case number, & review your household members in the household information section of the Parent Portal for accuracy, prior to starting the online application.

For families that receive benefits through Direct Certification through the State of WI, you will be notified of approval/denial of benefit prior to Aug. 8, 2018 via a mailed letter from the school district. If you did not receive an approval/denial letter, please fill out a F&R application online or pick up a paper copy in the district office.

Please check the school's website for updates in August or call the District office at 920-564-2346 between the hours of 9:00am & 3:00p.m., Monday through Thursday, if you have questions. Thank you.
